5. The general secretary shall also operate upon the trust bank account jointly with the signatures of the Chairman or Vice-chairman.

14. TREASURER

The power and duties of the treasurer shall be as under:

1. He/she shall be responsible for the regular and proper maintenance of the accounts of the trust and all its branches and institutions
2. To prepare and present the budget estimates, audited accounts of the trust on due dates and will perform the duty in sending the audited balance sheet to all the trustee and departments wherever required to be sent.
3. He/ She shall be empowered to sanction bills; cash memos up to Rs. 50000 (Rupee Fifty Thousand Only) but such total amount will not exceed Rs. 200000 (Rupee Two Lakhs Only) in a month. The above stated monetary limit may increased by a resolution passed by the majority of the trustees considering the needs from time to time.
4. To use such other powers and to perform such other functions as may be necessary for the due discharge of his duties as finance secretary of the trust.

15. REMOVAL FROM MEMBERSHIP:-

Subject to the mutual agreement by all the trustees, any life member or honorary member of the trust shall be removed from the membership of any council or committee on any one of the following grounds:-

- I) For acting in any way prejudicial to the interest of the trust.
- II) Failing to pay the subscription due to trust.
- III) Have failed to perform the duties entrusted to him.
- IV) Due to insolvency, criminal conviction by any court, insanity and immorality.
